A narrative statement not to exceed 500 words describing the overall capability and performance of the nominee in the role of an Extension Administrative Assistant.

In the narrative statement, include any special duties performed by the nominee and any special accomplishments. This will help the judges in their decision-making process.

Award:

The winner receives a plaque and \$200 cash at the GACAA AM/PIC Awards Banquet

Recipients must attend GACAA Annual Meeting/Professional Improvement Conference to receive awards, unless exempted by GACAA President because of extenuating circumstances. (Established by GACAA Board action, November, 2008)
